In addition, Christian liberty can mean that Christians are freed from the Jewish Law of Moses in that the Law only "exposes" sin in one's life but cannot "forgive" sin (Romans 3:20-22). Finally, Christian liberty can mean that Christians are freed in respect to such activity that is not expressly forbidden in the Bible.
